



## PHOENIX LANDING FOUNDATION PARROT ADOPTION AGREEMENT

Thank you for adopting a parrot from Phoenix Landing. Please contact us with any questions you may have about bird care, we are happy to help. Our email is [contact@phoenixlanding.org](mailto:contact@phoenixlanding.org)

Please review and initial the following:

I agree to inform Phoenix Landing within 10 days of any changes to my contact information (email, phone number, or physical address). Updates should be sent to [contact@phoenixlanding.org](mailto:contact@phoenixlanding.org) or Phoenix Landing, PO Box 459, Alexander NC 28701.

I agree that the parrot will NEVER be placed in a breeding situation.

I agree to contact Phoenix Landing if the parrot needs a new home for ANY reason and to allow Phoenix Landing to find that home.

I agree NEVER to sell or transfer this parrot to anyone other than the Phoenix Landing Foundation. I agree that the bird must be returned to Phoenix Landing in the event that I can no longer care for it, do not want it, or upon my death or disability.

I have never been convicted of animal cruelty, neglect, or abandonment.

I agree to respond to requests for updates on the parrot within a reasonable time. An alumni coordinator may contact you for these updates every year or so.

This parrot adoption agreement (the "Agreement") is entered into for mutually acknowledged and valuable consideration, as of the \_\_\_\_\_ day of \_\_\_\_\_, 2019. Primary Caregiver affirms that the responses given in the initial foster or adoption application are accurate and complete. The Primary Caregiver agrees to give the parrot a healthy environment and to care for him with common sense, respect, and decency. He/she is to be treated as a member of the family.

If Phoenix Landing determines at any time that the Primary Caregiver has not complied with the terms and conditions, or feels that it is not in the best interests of the parrot to remain at this location, Phoenix Landing has the legal authority by virtue of this contract to terminate this agreement and remove the parrot.

Primary Caregiver understands that under certain conditions parrots may develop undesirable habits, become destructive or carry diseases that can be transmitted to humans and other animals. Likewise, the Primary Caregiver understands that parrots require security and companionship, a nutritious diet (to include fresh whole foods), a healthy environment (safe, good ventilation, medical care), stimulation (toys, social activities & interaction), and a clean and large cage in which to live. All these things can be expensive and the Primary Caregiver is aware and capable of providing the proper resources.

Phoenix Landing makes no guarantees on health, behavior or talking ability; the parrot is delivered "as-is" and deserves to be loved accordingly. Primary caregiver agrees to be responsible for all veterinary care and states that providing such care is not a financial hardship. Primary caregiver agrees to take the parrot for checkups with a qualified avian vet on a regular basis (every 2 years recommended), and absolutely as needed at the first sign of illness.

Primary Caregiver shall defend, indemnify and hold harmless Phoenix Landing and its volunteers from all claims for actions, claims, damages, losses and expenses for personal injury or death to persons or injury to or destruction of property arising out of Primary Caregiver's performance or non-performance of this agreement. In the event of any dispute, adjudication or litigation between Phoenix Landing and the Primary Caregiver, Phoenix Landing shall recover all its losses, damages, including, but not limited to, its reasonable attorney's fees and costs. This contract shall remain in effect in perpetuity.

Primary caregiver understands that parrots can live for many decades. If for any reason the Primary Caregiver is no longer able to care for this parrot, \_\_\_\_\_ (adopter named in this agreement) will contact Phoenix Landing so that we can work together to ensure that the parrot's next home is a good one. The new caretakers, even if a family member or friend, will be required to submit an adoption application, and sign a new adoption agreement with Phoenix Landing so that Phoenix Landing never loses the legal chain of custody for \_\_\_\_\_ (parrot's name), a \_\_\_\_\_ (species).
